#### The Event

The Willow Time Trial is part of the Michigan Challenge Points series, and is a Nationally Ranked Event! The event consists of 6 laps on a flat course in a low traffic area for a total of 13.2 miles. Electronic timing provided by "The Timing Guys". Event will be held rain or shine. For start times and results visit <http://www.fredericjames.com/timetrials>.

#### Location

The Willow Time Trial will be held at Willow MetroPark. Willow MetroPark is located near Romulus Michigan, east of I-275 off of South Huron Road (exit 11), six miles south of I-94. Registration is at the "Pool - Activity Area." A park entrance permit is required. The one day permit cost is \$4.00 per vehicle unless you have an annual MetroParks permit that is available for \$20.

#### Event Rules

All USACycling rules apply. An ANSI/Snell approved helmet is required. No drafting is allowed. Riders are responsible for being at the start line on time; no time allowance will be given for late starts. Riders start 30 seconds apart.

A valid annual USCF license is required to compete in this event. **Your USCF License number MUST be included in your entry form.** Alternatively, we can sell you a day of event license (\$10) or annual license (\$60 for seniors, \$30 for juniors 18 or younger on December 31) as part of your entry; payment MUST be included with your entry form. A USACycling license application will then be filled out at day of event check in. A signed Standard USCF Athlete Release Form available at [www.usacycling.org](http://www.usacycling.org) should be included with your entry form, or it will be available at day of event check in.

#### **Senior riders with one day licenses may only race as Sr Men Cat 5 or Sr Women Cat 4.**

Riders participating in the Michigan Challenge Points series should enter the Willow Time Trial in their Michigan Challenge category.

Results will be posted after all riders have completed. There will be a 15 minute protest period. Riders may question any results with the USCF Chief Referee. At the end of the protest period the results are FINAL and the award ceremony will begin. No changes to results will be made after the protest period ends.

#### Prizes

1<sup>st</sup> place finisher in each category receives entry fee. Ribbons or medals will be awarded to the top 3 finishers in each category. Prizes and awards will be given out only during the award ceremony at the conclusion of the event. Prizes and awards will not be mailed out afterwards.
